## Grantsville man killed in firey crash south of Eureka

A Grantsville man was killed in a two-car accident on SR 6 south of Eureka on Thursday. Rod Miller, Grantsville, was

dead at the scene. Miller, the driver of a 2004 Chevy 2500, was traveling northbound on SR-6 at a high

rate of speed and drifted off the road to the right, said Nick Bowles, Utah Highway Patrol

Sgt.
"The vehicle came back to the

left and slid across the road into oncoming traffic," said Bowles.

At that point, a 1999 Ford F250, driven by Jack Naplin, 41, struck the Miller vehicle in the center pillar on the passenger

"After contact both vehicles

spun 90 degrees," said Bowles. The Miller vehicle came to rest off the road facing east-bound. The Naplin vehicle came to rest facing northbound in the southbound lane.

After coming to rest, the Miller vehicle caught on fire in the engine compartment. Witness on the scene were able to get the driver, Naplin, out of his vehicle but were not able to remove Miller from his vehicle.

"One of the witnesses was a medical doctor and stated that the driver in vehicle one (Miller) was an obvious fatal with head injuries and was unable to get him out," said Bowles.

Both vehicles were fully engulfed.

"Alcohol was found at the scene," said Bowles. "It is un-known if it is a contributing factor at this time.

Naplin suffered non-life threatening injuries. He was wearing a seat belt.

### County passes resolution to designate property in Mona as an enterprise zone

The Ray Garlick property in Mona is now recognized by the county as an enterprise zone.

The property, once owned by Garlick, now deceased, is located south west of the boy's home in Mona.

Glenn Greenhalgh, county planning director, said that By ron Woodland, county economic development director, had been working to have the area on the outskirts of Mona designated as an enterprise zone recognized by the state.

We have a number of enterprise zones in Juab county," said Greenhalgh.

After consideration, Juab County Commissioners passed a resolution designating the Garlick property as an enterprise

The Utah Enterprise Zone Program was established in 1988. An enterprise zone comprises an area identified by local elected and economic development officials and designated by the state. Under the program, certain types of businesses locating to, or expanding in, a designated zone may claim state income tax credits provided in the law.

The zone would allow Con-Fab California Corporation to receive special tax credits if they build a plant in Mona.

Phil French, Con-Fab owner. and Preston Nailer, his associ-

ate, met with Mona City Council in February to talk about the company and the reasons French is interested in constructing a plant in Mona.

They will now meet with the county planning commission. That meeting is scheduled for Wednesday evening during the planning commission's regularly

scheduled board meeting.
The Juab County Planning commission meets on the first Wednesday of each month in the Juab County Commission

Chambers at 7 p.m. "It doesn't cost the county anything to designate the property an enterprise zone," said Greenhalgh. "It does help the

Any city or county in the state of Utah may be eligible for enterprise zone designation. Application for designation must be made by a city with 10,000 or less population located in a county with 50,000 or less population, by a county with 10,000 or less population or an Indian Tribe for tribal lands. Applications will be reviewed and approved on the basis of economic development need, its quality, and other considerations based on a variety of economic distress factors.

Some of these may include: pervasiveness of poverty, unemployment, and general distress in the proposed zone; potential for new investment and economic development in the proposed zone, the applicant's proposed use of other state and federal

development funds or programs to increase probability of new investment and development occurring in proposed zone; the extent projected development in the zone will provide employment to residents in the zone, and particularly, individuals who are unemployed or economically disadvantaged.

Con-Fab has been manufacturing bridge girders since 1980, and Caltrans bridge girders since 1986.

Con-Fab is the only precast company located in the United States that is a member of the PTI (Post-Tensioning Institute) and, to date, Con-Fab has received two awards from P.C.I.: for bridges built in Los Angeles and for the H3 Freeway in Ha-

Rick Carlton, commissioner. said he did have some concerns he would like to have addressed by French and would like to make certain that the county consider the points.

"I strongly suggest we look at Con-Fab's California site," said Carlton.

One of his concerns was the roads in the county which would be used to haul the concrete and the possible deterioration of those roads as a result. That deterioration needs to be addressed and the place of entrance.

The Goshen road is built to a higher standard than were some
