The council received a report from the city planning commission which included three recommendations on specific land-use actions.

Glenn Greenhalgh, chairman of the planning commission, said that earlier that same evening a public nearing had been held by the planning commission.

He said that the planning commission was recommending an amendment to the zoning ordinance.

Following the discussion. council members directed Kasey Wright, city attorney, to prepare the necessary documents for council consideration at a future date. They gave approval to allow the initial structural work prior to the sale of lots.

The property for the subdivision is currently zoned R1-H which is a holding zone, he said. R1 is a single family housing subdivision where homes are built on at least one-quarter acre lots. However, these lots are somewhat larger.

"If the council desires to consider acting on the planning commission recommendation for a change to the zoning ordinance, the council can instruct the city attorney to prepare an ordinance to implement the amendment," said Randy McKnight, city administrator. "The council can then consid-

Greenhalgh said the council was also being asked to consider granting approval to the final plat for Covington Ridge Subdivision, plat D. The plat and associated construction plans have been reviewed by the city's development review committee and by the planning commission.

"It seems backward to me," said Mark Jones, mayor.

Approval of the final plat signals that the developer may prepare to commence the construction of subdivision improvements, once the plans have been signed by the public works director, and a preconstruction meeting has been

"The plat is not recorded until the subdivision improvements have been installed and inspected, and a warranty bond has been placed," said Greenhalgh. "This is one of the most carefully scrutinized subdivisions to date."

He said that Kyle Marchant, city public works director, had done an excellent job.

There was a fair amount of work to be done by the developer before any lots could be sold. The planning process was a long, drawn out procedure but the initial dirt work could be started with the stipulation that no lots could be sold until all the approvals were given.

## Students learn perils of drunk driving during mock accident

Even though it wasn't real, the scene of a drunk driving accident felt real as students watched fellow classmates participate in a mock accident ĥeld May 18 at Juab High

The scenario started off with a voice over of students making plans for the weekend. They seemed happy and ready to start the summer after graduating. The scene quickly changed as the students were heard getting into an accident and blue tarps were pulled off the cars revealing the aftermath of the crash, a head-on

Shelby Cameron, crash victim, was seen standing over the lifeless body of Hayley Willmore. The driver of the car, Jaxon Allred, was injured and dazed. Three more victims were trapped in the cars.

Quickly Nephi Police Department, Utah Highway Patrol, and Juab County Sheriff were dispatched to the scene. They responded to the victims' needs and started documenting the crash site. Juab County EMS and Nephi Fire Department were close behind and began administering medical aid as well as extricating the victims. The AirMed helicopter was also called out to the scene and landed in the field next to the crash site.

Allred was given a sobriety test by UHP Trooper Dustin Livingston and was found to be 1x over the legal limit. He was handcuffed and led to an
