The Zombies are coming, the **Zombies** are coming

A Zombie Chase, 5K race, planned for Eureka may not need to be permitted by Juab County even though it crosses Highway 6 inside the city.

Highway 6 is not a county road, it is a state highway.

Terry Brown and Trent Groot have planned a fundraising CharityVision Zombie Chase for Eureka to be held on June 22. "They applied for a mass gath-

ering permit," said Pat Ingram, county clerk/auditor.

The permit costs \$100 and there is also a fee of \$1,000 for a standby ambulance. However, the ambulance was usually needed for motorcycle races but this was a different sort of activity with the participants running.

Brown said that they had arranged for EMTs to be present in case a runner needed help but that they did not think an ambulance needed to be there on standby.

They did think having a deputy present where Hatfield Road crosses Highway 6 was important.

"Hatfield Road is the last road out of town," said Brown. "The Zombie Chase is entirely inside city limits.'

Brown said that the race is a 5K Adventure Run through a Zombie-infested Eureka in the thick of night under a full moon. There is a particularly dark alley in downtown Eureka that cannot be seen from Highway 6 that is anchored on one end by the Jail and is only for the brave of heart.

The Zombie Chase will be held during the night and is covered by liability insurance. The duo also had permission from UDOT to cross the highway and had all the other necessary documents.

They had come to the commission prepared to gain permission and the county permit signed by Chad Winn, as commission chairman.

"We have been meeting with Eureka City Council for several months," said Brown.

Ingram said that she would need to contact the sheriff and talk to him so that he would be aware of the event.

While the commission was discussing the permitting process, Jared Eldridge, county attorney, questioned why the county was even involved. Other than needing a standby deputy. there was nothing about the event that would require the county to be involved. "It is being held inside Eureka City," he said. "The highway the race will cross is a state highway. Winn said he had been wondering the same thing. However, he thought that the sheriff should be consulted by Brown and Groot. 'We can't approve anything that is to take place within the city," said Eldridge. The pair had been working with the city council in Eureka and had received the permission they needed to use city streets from the city. The city should be the permitting agent. They were directed not to make out a check to the county until they had met with the sher-iff and discussed their proposal with him.

'We need to be thinking about getting a new lawn mower for the city," said Frank Riding, council member. "The two we have are old and are beginning to nickel and dime us to death.

He said a new mower would be approximately \$6,000 and may be less for a trade-in.

I hate trade-ins," said Mills. "The original owner got rid of the equipment for a reason. I think we should increase the budget for a new lawn mower to \$8,000. The water department could use a water-finder.

Mills also suggested that in the city garage, a shelf might be installed to hold small items that belong to the city. Those types of items, if not stored properly, had a tendency to disappear.

The maintenance building needed wire racks installed to store items and to get them off of the floor.

Mike Stringer, council member, said the city needed to budget money for street signs and for the concrete that would be needed to install them.

Mills said that some wastewater plan improvements needed to be made, and those should be put into the budget for the coming year.

Road upkeep and repair need ed to be planned for as well.

We need to look at setting aside some money for a tractor, said Mills. "We also need to get a posthole digger for our own trac-tor so we can do our own work."

A pick-up truck and a street sweeper could be planned but would depend on what the state surplus had to offer.
