## Nephi City bans fireworks on east side of I-15

Nephi has a new ordinance prohibiting the discharge of fireworks on the east side of Interstate 15.

Justin Seely, acting as mayor pro tempore in the absence of Mark Jones, was authorized to sign the ordinance so that it could become effective immedi-

"We pass a new ordinance concerning fireworks every year," said Larry Ostler, council member. "Could we make an ordinance that would be permanent?"

Seth Atkinson, city administrator, said it is probably better to pass a new ordinance every year so that it is called to the attention of the public annually.

That way, the public is aware that there is an ordinance Nephi City Council has authority to pass ordinances to govern the affairs of the city which is granted under Utah

Code Annotated. Atkinson said that the fire chief is concerned that with hot weather and dry foliage, the city is in danger of a fire being caused accidentally that could create a wildfire which could, in turn, threaten homes

and structures. As everyone who watches the news knows, man-caused wildfires are already burning in the state, he said.

Fireworks cause a substantial number of fires in Utah on an annual basis.

Nephi City Council has authority to regulate and prohibit the discharge of fireworks and the council finds that an ordinance prohibiting the discharge of fireworks on the east side of Interstate 15 is in the best interest of the city and its

citizens. Nephi City Council finds that limitations on the use of fireworks are warranted to reduce the potential for damaging and costly forest and range

fires. The ordinance was adopted and reads as follows: "The city hereby prohibits and makes it illegal to discharge any fireworks within Nephi City on the east side of Interstate 15 and on property owned by Nephi City on the east side of Interstate 15.

"The effective date of this ordinance is the date on which it is published, June 28, 2017. This ordinance will sunset (expire) on December 15, 2017."

In 2005, Utah identified almost 600 communities and their surrounding natural resources as "at risk" from wildland fire.

One of those communities is Nephi. Eureka, Levan-East Bench, Mammoth, Mona-Willow/Mendenhall, Nephi-East Bench, Nephi-West Bench/Dog Valley, Rocky Ridge, Sevier

## School board adopts budgets at meeting

The Juab School District's proposed 2018 budget and final budget for 2017 were adopted following a budget hear-

Darin Clark, district business administrator, discussed the 2018 proposed budget, the 2017 final budget and the 2016 actual results at the budget hearing held Wednesday evening prior to the district meet-

Just a small handful of Interested patrons were in attendance as Clark began the discussion with a revue of the general fund revenue.

"Property tax revenue is budgeted to remain level, unless board chooses to go through Truth-In-Taxation,' said Clark.

There is an increase in state revenue due to 4 percent in-

crease in WPU (Weighted Pupil Unit) and growth, he said. Clark presented a pie chart

for the 2018 budgeted general

fund revenue by source show-

ing that local funds accounted for 23 percent, federal funds 6 percent and state funds 73

percent. "Personnel costs account for 89.4 percent of general fund expenditures," said Clark. "The district has approximately 575 employees and most are paid from the general fund."

The 575 employees include full-time equivalents (FTEs) who are "contract" employees. Of the 153 FTEs, 107 are teachers, 35.5 are classified employees and 10.5 are school or district administra-

He said that the 2017-2018 budget includes a 3 percent cost of living increase for all employees, the funding of step and lane increases and an increase of 1.6 percent in health

insurance premiums. The 2018 budgeted general fund expenditures by function are for student and instruction support at 7 percent, school administration at 6 percent, maintenance at 9 percent, transportation at 4 percent, general administration at 4 percent, business at 1 percent and instruction at 69 percent.

Also discussed was the 2018 budgeted general fund expenditures by object: textbooks and supplies represented 6.4 percent; purchased services another 3.4 percent; equipment is 0.5 percent; other represents 0.3 percent; personnel costs is 89.4 percent.

The School Activity Fund accounts for individual school revenue and expenses. The budget total is \$1.1 million for all schools, said Clark.

"Juab High School accounts for about half of the total," said

Clark also talked about the

non K-12 program. "There is \$490,000 budgeted to run non K-12 programs that include athletics and other extra-curricular activities, preschool and adult education,"

Growing programs include soccer and tennis, said Clark.

The Debt Service Fund includes \$1.23 million budgeted to pay bond principal and interest plus miscellaneous fees related to bond compliance and reporting.

The 2017-2018 Capital Outlay budget includes the following: \$1,160,000 of capital improvements including major projects, summer maintenance and equipment. It also includes bus and vehicle purchases and a contingency budget for unforeseen events

The fund includes \$600,000 for instructional equipment and supplies.
