Home builders in Mona must now provide culinary water before building

It will now be a requirement that all builders in Mona provide culinary water to the city before beginning construction.

City council members passed the resolution to add language to the ordinance, by way of resolution amending the ordinance, to require that all those building a home or requesting a subdivision provide culinary water.

"The resolution has most of the concerns that Allen Pay, city water operator, discussed with us," said Jeff Hearty, council member. "The burden will now be on the developer."

The resolution supported by unanimous decision of the city council was adopted as an amendment to the ordinance and was effective on August 25 upon signature of the mayor.

"The city has a water master plan," said Hearty. "We consulted the master plan and realized that the city would come up short unless we made some changes."

Hearty was assigned by the council to provide the language of the resolution. The resolution needed to be in place for the new code book the city is planning to adopt in the near future.

Two weeks ago there were some concerns with the adoption of the draft form of the resolution concerning water that each subdivision or lot must provide the city before any building can take place.

Pay had concerns about that

draft.

"I think all that you really need to do is require that there is an outdoor irrigation system that is equivalent to an acre foot of water," said Pay. "That will cover our one acre foot for our ERC (Equivalent Residential Connection) that is dedicated for outdoor use so they're not on the culinary system they have to have an irrigation

Future of Mona City Hall will be discussed at public hearing

Does the city hall in Mona need to be torn down and re-

The city council is interested in finding out what the people of Mona think about such a

The city council recently organized a Local Building Authority (LBA), in order to begin the process of considering the question and to review the CIB funding that will be available if the city meets certain crite-

"This city hall really needs to be replaced," said Mona-Mayor Greg Newton. "It is too small for the number of residents who come to a public hearing."

As another step in considering the possibility of building a new city hall, the Mona City Council will hold a public Council Chambers, located at 50 West Center Street.

"This building (the present city hall) is not earthquake proof," said Newton.

It was built by placing cement block upon cement block with no structural steel to reinforce the construction. Newton said he had observed the construction of the small building and knew that there was no structural steel added.

"The meeting room is extremely small," said Newton.

The LBA of Mona City will conduct the public hearing regarding construction of a new Mona City Center Building.

"The public is invited to receive information and give comment on the proposed project," said Lyla Spencer, city recorder. "We are advertising for the public hearing."

The purpose of an LBA is to acquire, improve, or extend

hearing at 7 p.m. on Tuesday, one or more projects and to fi-tending one or more projects September 8, in the Mona City nance their costs on behalf of and financing their costs on the public body that created it (in this case, Mona City Council), in order to accomplish the public purposes of the city.

The Local Building Authority of Mona finances building projects, such as constructing a new city hall and seeking funding from the Permanent Community Impact Fund Board (CIB) for this project. It does not, however, finance operations and maintenance.

All interested persons will be given an opportunity to be heard.

The notice of the meeting will be posted at the Mona City Office Building, Mona City Post Office and Gaydene's Sweet Art, and published on the Utah State Website and in the Nephi Times News.

"We are proposing that this building be razed," said New-

He said that the council was proposing a new building be built on the city park site.

The city council has the authority to organize a nonprofit corporation as the local building authority, following the procedures set out by state law, solely for the purpose of acquiring, improving, or exbehalf of the public.

The members of the Mona's Local Building Authority are the mayor and city council

members. A building authority may contract for or employ all staff and other personnel necessary for the purpose of performing its functions and activities, including contracting with the city council to utilize the personnel, property, or facilities for the purpose of the project, and may include the costs of the contracted services and employed staff and personnel in the rentals and charges payable to it under leases or agreements between it and the public body.

Except for those services that are paid for from bond proceeds, the building authority may include the cost of legal, accounting, and auditing services in the rentals and charges payable to it under leases or agreements between it and the public body.

"We would like many residents to show up at the public hearing to let us know what they think about the proposal to build a new city hall," said
